This Data Protection Notice (*DPN*) provides information about the processing and the protection of your personal data.

1. Introduction

The European Commission is committed to protect your personal data and to respect your privacy. The Commission collects and further processes personal data pursuant to Regulation (EU) 2018/1725 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

This Data Protection Notice (*DPN*) explains the reason for the processing of your personal data in the context of *Meeting of the Western Balkans Steering Platforms on Culture, Education and Training & Research and Innovation (Skopje, 3-5 June 2024).* It explains the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. It also specifies the contact details of the responsible Data Controller with whom you may exercise your rights, the Data Protection Officer and the European Data Protection Supervisor.

The information in relation to processing operation *Meeting of the Western Balkans Steering Platforms on Culture, Education and Training & Research and Innovation (Skopje, 3-5 June 2024)*, undertaken by the Directorate-General for Research and Innovation (*DG RTD*) of the European Commission, is presented below.

2. Why and how do we process your personal data?

<u>Purpose of the processing operation</u>: the Controller collects and further processes your personal data to provide you with information about the *Meeting of the Western Balkans Steering Platforms on Education and Training & Research and Innovation (Skopje, 15-16 February 2023) (before, during and after) and to process your application for participation in that meeting.*

Live web-streaming and audio-visual recording at the *Meeting of the Western Balkans Steering Platforms on Education and Training & Research and Innovation (Skopje, 15-16 February 2023)* of the speakers, organisers and participants, as well as photographs of the speakers and panoramic photographs of participants and organisers will be taken and published in the context and published in the context of the event or meeting at a site or place indicated in the specific consent forms linked to this meeting/event.

The audience or non-speaker participants are not photographed individually or in groups. They may however appear on panoramic photographs of the whole event/audience.

The data controller shall not be held accountable for any processing of personal data that you might carry out on your own initiative during or after the event. For instance, if you decide to take photographs/audio-visual recordings of participants of the *Meeting of the Western Balkans Steering Platforms on Culture, Education and Training & Research and Innovation (Skopje, 3-5 June 2024)* and/or publish them online, you assume full responsibility for these actions.

3. On what legal ground(s) do we process your personal data?

The processing operations on personal data, linked to the organisation, management, follow-up and promotion of the *Meeting of the Western Balkans Steering Platforms on Culture, Education and Training & Research and Innovation (Skopje, 3-5 June 2024) (including web-streaming, photos, audio-visual recording)* are necessary for the management and functioning of the Commission, as mandated by the Treaties. Those provisions are in particular Article 11 of the Treaty on European Union and Article 15 of the Treaty on the Functioning of the European Union.

Consequently, those processing operations are lawful under Article 5(1)(a) of Regulation (EU) 2018/1725 (processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Union institution or body).

The processing operations on personal data of the speakers for the *Meeting of the Western Balkans Steering Platforms on Culture, Education and Training & Research and Innovation (Skopje, 3-5 June 2024)* with whom a contract is concluded, are carried out in line with the contractual provisions. Consequently, that processing is necessary and lawful under Article 5(1)(c) of Regulation (EU) 2018/1725 (processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract).

If you opt-in, you are giving us your explicit consent under Article 5(1)(d) of Regulation (EU) 2018/1725 to process your personal data for those specific purposes. You can give your consent via a clear affirmative act by ticking the box(es) on the online registration form.

Your consent for any of these services can be withdrawn at any time, e.g. for unsubscribing from the newsletter by clicking on the 'unsubscribe button' if any, or by sending an email to the contact point of the Controller indicated in Heading 9.

4. Which personal data do we collect and further process?

The following personal data will be processed:

- Identity (function/title, first name, last name, name of organisation, city, country);
- Contact details (e-mail address, telephone number);
- Nationality, passport or identity card number and its date of issue and expiry date may be collected for further travel arrangements and so that the data subjects may obtain access to the premises where the meeting/event is held;
- Dietary requests or specific access requirements.

5. How long do we keep your personal data?

The Data Controller only keeps your personal data for the time necessary to fulfil the purpose of collection or further processing.

For each of the categories of personal data that is processed, please find below the retention details and the reference to the relevant record of processing

All personal data related to the organisation and management of the Meeting of the Western
Balkans Steering Platforms on Culture, Education and Training & Research and
Innovation (Skopje, 3-5 June 2024) (this includes the information given during the
registration, before, during or after the event) will be deleted 5 years after the last action
in relation to the Meeting of the Western Balkans Steering Platforms on Culture, Education
and Training & Research and Innovation (Skopie, 3-5 June 2024):

Sensitive personal data relating to dietary and/or access requirements will be deleted as
soon as they are no longer necessary for the purpose for which they have been collected in
the framework of the Meeting of the Western Balkans Steering Platforms on Culture,

Education and Training & Research and Innovation (Skopje, 3-5 June 2024), but no later than within 1 month after the end of the Meeting of the Western Balkans Steering Platforms on Culture, Education and Training & Research and Innovation (Skopje, 3-5 June 2024); Recordings from the web-streamed Meeting of the Western Balkans Steering Platforms on Culture, Education and Training & Research and Innovation (Skopje, 3-5 June 2024) will be kept for 2 years before being deleted. More information is available in the Record of Processing DPR-EC-00306 (Web-streaming of Commission events); Photo's and video's for which consent was obtained through duly completed and signed Consent Form(s) for the Event will be kept for 2 years. Their publication in the channels identified in the Consent Form will follow the longevity of the content posted therein, unless consent was redrawn at an earlier stage In case of audio-visual recording of the Meeting of the Western Balkans Steering Platforms on Culture, Education and Training & Research and Innovation (Skopje, 3-5 June 2024), the recordings will be kept for **3 months** after the *Meeting of the Western Balkans Steering* Platforms on Culture, Education and Training & Research and Innovation (Skopje, 3-5 June 2024), before being deleted. More information is available in the Record of Processing DPR-EC-01937 (Audio-visual recording of meetings); Personal data shared with the controller for future mailing purposes (e.g. for receiving newsletters or invitations to similar events) are processed in line with the Record of Processing DPR-EC-03928 (Management of subscriptions to receive information) and the specific privacy statement prepared by the organising Commission service); Selected service providers for organisational purposes (such as caterers, travel agents or event management organisations) are contractually bound to process personal data on behalf of and in line with the instructions of the data controller, keep confidential any data they process and protect it from unauthorised access, use and retention.

6. How do we protect and safeguard your personal data?

All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.) are stored on the servers of the European Commission (and of its contractors if contractors are engaged to assist the controller in the organisation and management of this meeting/event].

All processing operations are carried out pursuant to <u>Commission Decision (EU, Euratom) 2017/46</u> of 10 January 2017 on the security of communication and information systems in the European Commission.

In order to protect your personal data, the Commission has put in place a number of technical and organisational measures. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of given processing operations.

The Commission's contractors are bound by specific contractual clauses for any processing operations of your personal data on behalf of the Commission, and by the confidentiality obligations deriving from the General Data Protection Regulation ('GDPR' - <u>Regulation (EU)</u> 2016/679).

7. Who has access to your personal data and to whom is it disclosed?

Access to your personal data is provided to the Commission staff responsible for carrying out this processing operation and to other authorised Commission staff according to the "need to know" principle. Such staff abide by statutory, and when required, additional confidentiality agreements.

As the controller uses (a) service provider(s) (processor(s)) to assist in the organisation of this event, the controller also shares your information with this/these service provider(s) for the purposes of organising this event.

- derogation(s) for specific situation(s), if there is no adequacy decision for the respective third countries / commercial sectors, and no appropriate safeguards for transfer. Please note that pursuant to Article 3(13) of Regulation (EU) 2018/1725 public authorities (e.g. Court of Auditors, EU Court of Justice) which may receive personal data in the framework of a particular inquiry in accordance with Union or Member State law shall not be regarded as

recipients. The further processing of those data by those public authorities shall be in compliance with the applicable data protection rules according to the purposes of the processing.

The information we collect will not be given to any third party, except to the extent and for the purpose we may be required to do so by law.

8. What are your rights and how can you exercise them?

You have specific rights as a 'data subject' under Chapter III (*Articles 14-25*) of Regulation (EU) 2018/1725, in particular the right to access, your personal data and to rectify them in case your personal data are inaccurate or incomplete. Where applicable, you have the right to erase your personal data, to restrict the processing of your personal data, to object to the processing, and the right to data portability.

You have the right to object to the processing of your personal data, which is lawfully carried out pursuant to Article 5(1)(a) of Regulation (EU) 2018/1725 on grounds relating to your particular situation.

The data will ensure that the data subjects can exercise their right to object to processing whenever possible by the organisers of the meeting/event (for example, on the spot by indicating a non-web streamed seat if requested; or ex-post, by deleting a specific sequence from the online video/voice recording).

You can exercise your rights by contacting the data controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor.
